## **WAIVER/RELEASE OF LIABILITY**

In consideration of my participation in the 2022 Waterbury Adventure Challenge (“The Event”), I hereby waive, release, and discharge any and all claims for damages, death, personal injury, or property damage which I may have, or which hereafter accrue to me, as a result of my participation in this event. This release is intended to discharge in advance Revitalizing Waterbury and any involved municipalities or other public agencies from and against any and all liabilities arising out of or connected in any way with my participation in the Event. I further understand that serious accidents may occur during the Event and that participants occasionally sustain serious or mortal personal injuries and/or property damage as a consequence thereof. Knowing the risks of the Event, nevertheless, I hereby assume those risks and do hold harmless all persons or entities related to Revitalizing Waterbury, involved municipalities and public agencies, and all persons involved in producing this Event, who (through negligence or carelessness) might otherwise be liable to me (or my heirs or assigns) for damages. It is further understood and agreed that this waiver, release and assumption of risk, is to be binding on my heirs and assigns. By signing this release, I hereby agree to the terms of this release.

## **AGREEMENT OF REFUND POLICY**

I, the undersigned, agree that from this point forward, I have officially begun the Event under my own free will and therefore am no longer eligible for a refund under any circumstances, included but not limited to weather, emergencies, difficulty of the Event, or physical/mental inability to complete the event.

If you can't figure it out, you can read the answers when they are posted in late October.
- \* Please **DO NOT** contact any event organizers, participating businesses, or other event partners asking for clues. We will respond by saying, “We can't give out clues.”
- \* **DO NOT TRESPASS ON PRIVATE PROPERTY!** You won't find anything inside someone's house!
- \* You do not need to move, lift, dig, or destroy anything. Respect nature. Leave no trace.
- \* To be fair to all adventurers, each team member (15 and older) must pay the registration fee. Any team caught participating with unpaid team members will be disqualified.
- \* You must follow all travel and safety rules and guidelines, including but not limited to those set forth by the state of Vermont, town of Waterbury, and any businesses or properties on which the Event takes place.

## **PRIZES**

- \* All individuals who complete the Event will be eligible for the grand and monthly prize drawings.
- \* All players, whether they complete the Event or not, are eligible to win other prizes through the Ticket to Prizes, or by encountering other bonus prizes throughout the Event.
- \* Beyond the tickets required of all participants, there is no additional purchase necessary to play or win.
